The League of Miracles is a welcoming place for kids and adults with disabilities along with their families and caregivers to participate in recreational activities, sports leagues and social activities.

Mission

The mission of the League of Miracles is to provide a fun and safe recreational atmosphere for kids and adults with disabilities and their families.

About the Field

The field is a full-size baseball field made entirely of rubber so players who use wheelchairs or walkers can round the bases safely. Our 40x60-foot air-conditioned building is equipped with a large community room, concession stands, bleachers, ample parking and 4 fully accessible ADA restrooms. In addition, we have a fully functioning electronic scoreboard and in 2023, field lights were installed for evening play.

Board Member Responsibilities

Time Commitment

Board meetings are held virtually via Zoom at 7:30 AM on the second Friday of each month. It is encouraged that each board member serves on a committee that would generally meet monthly. Board members are also asked to attend special events throughout the year.

Term

Board members will serve for a term of two(2) years.

Attendance

Board members shall attend no less than seventy-five (75) percent of all Board Meetings and meet requirements per by the Governance Committee

Legal Duties

Duty of Care requires that each board member shall have a responsibility as a steward of the organization.

Duty of Loyalty requires each board member to uphold a standard of faithfulness and allegiance to the organization by avoiding conflicts of interest.

Duty of Obedience requires board members to comply with governing documents (i.e. Bylaws, Articles of Incorporation, policies, etc.)

Board Member Core Duties

Ensure effective planning. Boards must actively participate in an overall strategic planning process and assist in implementing and monitoring the plan's goals.

Ensure adequate financial resources. One of the foremost responsibilities is to secure adequate on -going financial resources for the organization to fulfill its mission

Protect assets and provide financial oversight. The board must assist in developing the annual budget and ensure that proper financial controls are in place.
